BRINLIE STEVENS, a high school senior from Scott Community High School, recently returned from the 2024 National Rural Electric Cooperative Association (NRECA) PowerXchange in San Antonio, Texas.

The leadership learning experience from March 3-6 was a whirlwind according to Stevens, who served as a volunteer with fellow Youth Leadership Council (YLC) delegates from 44 states.

"[The conference] made me more aware of how necessary and vital electric cooperatives are in rural communities," Stevens said. "I now have a better understanding of why it's so important that NRECA makes these youth events. Getting our generation interested in co-ops ensures the future for electric cooperatives is bright. This week also has shown me that I am braver and more outgoing than I thought!"

YLC delegates opened the conference during the general session, in front of thousands of representatives from electric cooperatives from across the country. YLCs introduced speakers, passed out microphones, counted attendance and other various conference tasks.

Stevens represented Wheatland Electric Cooperative, Inc. (WEC) during the Electric Cooperative Youth Tour to Washington, D.C., in June 2023. During Youth Tour, she was selected as the Kansas YLC delegate by her peers.

"My favorite part of this week was watching my fellow YLC delegates perform their talents at the talent show and seeing Josh Turner," Stevens added, referring to the country and gospel singer and songwriter who provided entertainment during the close of the conference.

Our succession planning identifies and develops future leaders within the co-op to ensure continuity of leadership and smooth transition of key roles. These employees also learned from their successors.

NICOLE SEMENKO, former payroll specialist, steps into her new role as manager of human resources, following the retirement of BARBARA KIRK, who served WEC for nearly two decades.

Kirk, who retired March 8, started her career with WEC in October 2005, as a payroll specialist and was later promoted to manager of human resources in December 2015. Kirk became the human resources director in December 2017.

"I'm very thankful for the opportunities I have been given and the learning and growing I have done," Kirk said. "I've worked on projects with many people over the years and have made friendships. I feel by doing the many HR functions, I've helped my fellow employees serve our communities."

KLAUS TO RETIRE: BARRETT. **PETERSON PROMOTED**

RICK KLAUS, director of operations, has announced he will retire Sept. 6, 2024. Klaus' career began at WEC in April 1982, as a groundman in District 5 (comprising Finney, eastern Kearny, and northwestern Gray counties). In November 1985, he was promoted to journeyman lineman, and then to District 5 foreman in 1990. In June 1998, he was promoted to foreman of the District 5 substation crew. Klaus became the District 5 manager in May 2014, and ultimately in charge of operations across Districts 1-5 in December 2015. In December 2018, he was

promoted to director of operations for all of WEC.

"Rick has done a tremendous job during his service to WEC," said Bruce W. Mueller, CEO/general manager. "He has earned the admiration and respect from the members and employees who have worked with him over his 42-yearlong career."

BRANDON BARRETT, WEC's manager of engineering since December 2020, has over a decade of experience at WEC. He is currently training alongside Klaus to step into the director of operations position upon Klaus' retirement. Barrett started his WEC career as a part-time engineering summer intern in 2009, before completing an additional three internships with WEC during college. In December 2011, he was hired as a full-time electrical engineer. In December 2017, he was promoted to electrical engineer II and ultimately manager of engineering, his current role, in December 2020.

To fill the role previously held by Barrett, **CURTIS PETERSON**, formerly District 5 manager, has been promoted to manager of operations. In this new role. Peterson is responsible for assuring that the WEC electrical facilities are constructed, maintained and operated in a safe, efficient and consistent manner across all WFC districts and meet National Electrical Safety Code (NESC) code requirements. He is also responsible for assuring that adequate planning occurs for the orderly development of distribution and substation facilities and will be working with WEC's Manager of Safety Quinten Wheeler to promote safe and efficient work practices for all operations personnel.

Peterson has served WEC since June 1993, when he was first hired part time as a member of a District 5 line crew. He was promoted to journeyman lineman in December 1996, and District 5 manager in December 2018.

For the third year in a row, Wheatland Electric Cooperative, Inc. has received national recognition in the 2024 **SPOTLIGHT ON EXCELLENCE AWARDS** program, sponsored by the Council of Rural Electric Communicators (CREC) and the National Rural Electric Cooperative Association (NRECA).

WFC's member services team received a SILVER AWARD IN BEST **EXTERNAL EVENT** for our 75th anniversary celebration at our 2023 annual meeting and a second SILVER AWARD IN BEST WILD CARD for our 75th historical display.

The 2023 event, held April 26 in Scott City and in seven additional remote locations across WEC's service territory, was attended in record numbers by co-op members across southwest and central Kansas.

The meeting's theme, "Feel the Power," reflected 75 years of shared cooperative history with the membership. WEC received its official charter from the Rural Flectrification Administration in 1948.

Member services, with the help of additional cooperative employees, put together a special publication and life-size historical exhibit in Scott City as part of last year's annual meeting celebration, reflecting the co-op's many decades of service and rich history. Both the publication and exhibit featured historical documents and artifacts. A copy of the special publication (our 2022 annual report) is available online at www.weci.net/ annual-meeting.

"I'm extremely proud of our member

services team and the work they've done to catalogue and document our rich cooperative history," said Bruce W. Mueller, WEC's CEO/general manager. "Because of their strong communication efforts, we will be able to share our story and carry out our mission for decades to come."

The member services team is led by **ALLI CONINE**, director of member services and corporate communications, and includes the following team members: SAMANTHA GARCIA and MARY HOISINGTON. both member services and key accounts managers; and SHAJIA DONECKER, social media specialist.

The member services team will be recognized at the 2024 CONNECT Conference in Baltimore, Maryland, a national conference for communications and marketing professionals in the cooperative electric industry later this May. Donecker will accept the awards and participate in this annual professional development opportunity.

The Spotlight on Excellence program recognizes the best communication and marketing efforts by electric cooperatives and related organizations nationwide. More than 800 entries were submitted across 20 categories from just under 180 co-ops representing 40 states. Categories include writing, graphic design, digital communications, campaign development and more. The judging panel includes members from the University of Missouri as well as noted professionals in the fields of marketing, digital communications and print media.
